## **RESOLUTION NO. 01092013-01**

A RESOLUTION of North County Regional Fire Authority ("NCRFA"), authorizing the Fire Chief of NCRFA to dispose of the 1979 Ford Engine that has been declared surplus to the needs of NCRFA; and providing for other matters properly related thereto.

## A RESOLUTION AUTHORIZING THE FIRE CHIEF TO SELL SURPLUS FIRE ENGINE AND SPACE PUMP PARTS.

WHEREAS, NCRFA has previously declared the fire engine surplus to its needs;

WHEREAS, Resolution No. 01092013-01 replaces Resolution No. 06132012-01 changing the minimum bid from \$5,000.00 to \$2,500.00. This is due to the replacement of the four rear tires that were in excellent shape and switched them with four tires off another apparatus that needed to be replaced.

WHEREAS, the Board of Fire Commissioners deems it appropriate to authorize the Fire Chief to sell the fire engine and spare pump parts to the highest bidder with a minimum bid of Two Thousand Five Hundred Dollars (\$2,500.00).

NOW, THEREFORE, THE BOARD OF NORTH COUNTY REGIONAL FIRE AUTHORITY HEREBY RESOLVES as follows:

<u>Section 1.</u> FIRE ENGINE. The Fire Chief of North County Regional Fire Authority has the authority to sell the fire engine and spare pump parts for a minimum bid of \$2,500.00.

<u>Section 2.</u> IMPLEMENTATION. The Fire Chief of NCRFA is authorized to implement such administrative procedures as may be necessary to carry out the directives of this legislation.

<u>Section 3.</u> EFFECTIVE DATE. This Resolution shall be in full force and effect upon passage and signatures hereon.
