<u>Section 2.</u> IMPLEMENTATION. The Fire Chief of NCRFA is authorized to implement such administrative procedures as may be necessary to carry out the directives of this legislation.

<u>Section 3.</u> EFFECTIVE DATE. This Resolution shall be in full force and effect upon passage and signatures hereon.
