#### **RESOLUTION NO. 10232013-02**

A RESOLUTION of North County Regional Fire Authority ("NCRFA"), authorizing the Fire Chief of NCRFA to dispose of the 1994 International Fire Engine that has been declared surplus to the needs of NCRFA; and providing for other matters properly related thereto.

# A RESOLUTION AUTHORIZING THE FIRE CHIEF TO SELL SURPLUS FIRE ENGINE.

WHEREAS, NCRFA has previously declared the fire engine surplus to its needs;

**WHEREAS**, Resolution No. 10232013-02 replaces Resolution No. 07102013-01 changing the minimum bid from \$25,000.00 to \$10,000.00. This is due to advertising for bids at \$25,000.00 and not receiving a single bid.

**WHEREAS**, the Board of Fire Commissioners deems it appropriate to authorize the Fire Chief to sell the fire engine to the highest bidder with a minimum bid of Ten Thousand Dollars (\$10,000.00).

NOW, THEREFORE, THE BOARD OF NORTH COUNTY REGIONAL FIRE AUTHORITY HEREBY RESOLVES as follows:

<u>Section 1.</u> FIRE ENGINE. The Fire Chief of North County Regional Fire Authority has the authority to sell the fire engine for a minimum bid of \$10,000.00.

<u>Section 2.</u> **IMPLEMENTATION.** The Fire Chief of NCRFA is authorized to implement such administrative procedures as may be necessary to carry out the directives of this legislation.

<u>Section 3.</u> EFFECTIVE DATE. This Resolution shall be in full force and effect upon passage and signatures hereon.

# **RESOLUTION NO. 11262013-1**

WHEREAS, the Board of Commissioners of North County Regional Fire Authority has met and considered its budget for the calendar year 2014; and

WHEREAS, the Board of Commissioners of North County Regional Fire Authority after hearing and after duly considering all relevant evidence and testimony presented, determined that North County Regional Fire Authority requires a regular levy in the amount of \$2,715,050.00, which includes an increase in property tax revenue from the previous year, and amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amounts authorized by law as a result of any annexations that have occurred and refunds made, in order to discharge the expected expenses and obligations of the district and in its best interest; and

WHEREAS, the population of the district is more than 10,000 and now, therefore,

**BE IT RESOLVED** by the Board of Commissioners of North County Regional Fire Authority that an increase in the regular property tax levy is hereby authorized for the 2014 levy in the amount of \$426,882.00 which is a percentage increase of 18.7% from the previous year.

This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.
