JUST A SHOUT OUT TO THE WHOLE DEPARTMENT FOR ALL THE PROGRESS WORKING TOGETHER ON COMPLETING THIS PHASE OF THE TRAINING CENTER.

- \cdot Labor Management Committee met. We received a grievance we are working through with the Local.
- \cdot Paul Ellis and I met for our first meeting since the new Fire Prevention ILA. AC Goforth provided data to share for the meeting. We are within our boundaries of spending for annual inspections.
- · The Snohomish County Training Consortium Admin Chiefs met and discussed the impending academy start at the training center. I shared that the AILA with EvCC would have to be individualized due to the Consortium not being a legal, separate entity. That ILA should be before you next meeting.
- \cdot Dave Somers office visited the training center to view the site where the ARPA funds are proposed to be used and the viability of the project. They were very pleased with the project and expected outcomes for fund usage.
- \cdot I met with South County Fire personnel regarding a possible use of the training center. Their Edmonds sister city is visiting from Japan and they would like to expose them to the training cadre and the current county fire academy on the training site in November.

- \cdot More work was completed on the FD21 EMS contract. We will move forward with your direction from this meeting.
- · AC Goforth is hosting a Fire Inspector class that meets the intent of certifying our officers as ICC Fire Inspectors once they have completed the test.
- · I met with Captain Abrahamson and MFD Captain Bailey regarding County Haz Mat needs.
- \cdot I attended a meeting in Everett today regarding the potential for utilizing a program called Nurse Navigator. NSACH has agreed to fund the first year to gather full data on utilization. It would reduce unnecessary ER transports and divert them through Lyft to local clinics where possible or in-home personal care in lieu of hospital transport. This was shared at the last Sno Isle Commissioners meeting. Implications for us would be a reduction in revenue from transports (less than 5%), lesser wall time at hospitals, greater unit availability, and more efficient use of resources.
