### **CHIEF'S REPORT**

Chief Cermak met with Mike Despain of MED Enterprises to discuss scheduling strategic planning. Community involvement day will be Saturday, December 7, 2024. December 9 and 10, there will be 2 internal work days scheduled for those that are on the Strategic Planning Committee. The sessions will be from 9:00 am to 12:00 pm (noon) for all 3 days.

A negotiations prep session was completed with both the local and management team. Chief expressed thanks to Greg Koontz, Nich Sacha, and Kirk Normand for spending time to share and understand all of the things on the table. Chief felt the process and time was well spent. A management meeting followed to help expedite and take those concepts into consideration to move the process forward to meet the year-end goal of achieving and completing a contract for the collective bargaining agreement.

Chief Cermak and Chief Kraski attended the County Fire Chief's meeting.

Chief Cermak had received calls about the PowerPoint presentation that was presented at the SnoCo Fire Commissioners meeting regarding SCEMS, now Snohomish County EMS. That group has had some challenges for many years, tasked with a large amount of work relating to County EMS providers. Over the last year, there has been a lot of work by a committee to restructure the interlocal agreement between SCEMS and the provider agencies with suggested changes. Since it started, Snohomish County EMS has doubled in population, which has created challenges. Chief will continue to bring updates and is hopeful there will be a resolution in the near future.

Chief worked on prepping for the initial meeting with Liz Loomis.

Chief expressed thanks to AC Goforth and his team for their work and preparation for the 9/11 events.

Chief attended a county Flock System demonstration. This type of intelligence has been helping communities like Arlington in solving crimes. As relating to emergency response, a benefit to our Command Staff would be a drone could arrive on scene to an incident quicker, and offer and aerial views. This technology has the ability to keep personnel safer and get the appropriate response to a scene quicker. Chief recalled a long-term vision that in rural communities, you may one day see drones dropping off AEDs to families.

PHOENIX AWARD PRESENTATION – Chief John Cermak presented NCRFA part-time Firefighter / EMT, Kyle Danz with a Phoenix Award. Recently, while off duty, Kyle was alerted via the Pulse-Point app that a citizen near his home needed CPR. Kyle led of team through the cardiac arrest, providing CPR, managing the AED with several shocks, and ensuring 9-1-1 was contacted for the response of Bellingham Fire. The patient is recovering in the hospital. Thank you for your selfless service, Kyle!
