**A RESOLUTION OF THE BOARD OF COMMISSIONERS OF NORTH COUNTY REGIONAL FIRE AUTHORITY, PURSUANT TO RCW 29A.76.010 REDISTRICTING COMMISSIONER DISTRICTS TO ADJUST TO 2022 U.S. CENSUS DATA**

**WHEREAS**, the North County Regional Fire Authority has received the 2022 federal decennial census information applicable to the North County Regional Fire Authority;

**WHEREAS**, the North County Regional Fire Authority is a special purpose district with a governing body comprised by internal director districts delineated in chapter 29A.76.010 of the Revised Code of Washington and is obligated to respond accordingly to receipt of census data;

**WHEREAS**, the North County Regional Fire Authority has conducted a review of the census data relative to the criteria established by Chapters 52.26.080 and 29A.76.010(4) of the Revised Code of Washington resulting in the development of modifications to its commissioner districts;

**WHEREAS**, a public hearing was advertised on the North County Regional Fire Authority website and held on November 09, 2022, for the purpose of presenting the proposed North County Regional Fire Authority director districts revisions and to receive related public comments; and

**WHEREAS**, after hearing and considering public comment relative to the proposed commissioner district revisions for more than one week, pursuant to Chapter 29A.76.010(5) of the revised Code of Washington, the North County Regional Fire Authority Governing Board has determined that commissioner district revisions are necessary to provide for constituent needs and to comply with statutory requirements.

**NOW, THEREFORE BE IT RESOLVED** that the North County Regional Fire Authority Governing Board adopts the commissioner revisions presented and directs the Board Secretary to so notify the appropriate Snohomish County officials.
