

## North County Regional Fire Authority Resolution 10222024-01

### RESOLUTION TO AMEND TRAINING CENTER FEE SCHEDULE

**WHEREAS**, the Board of Fire Commissioners of North County Regional Fire Authority did establish a training center fee schedule on June 14<sup>th</sup>, 2023; and

**WHEREAS**, the initial fee schedule for use by the Snohomish County Fire Academy was established on forecasted revenues and expenses for the operations of the training center; and

**WHEREAS**, the training center now has had a year of actual expenses which allows for the more accurate reporting and assessment of actual operational costs; and

**WHEREAS**, North County RFA would like to amend the training center fee schedule for the Snohomish County Fire Academy to better reflect the actual costs of operating a training center.


**WHEREAS**, the Board has determined that the following fee schedule is fair and equitable recompense for the use of equipment and facilities at the Training Center;




