Chief Cermak provided the Commission with a new letter addressed to District 21 regarding a potential contract. Direction was given to the Fire Chief to continue communicating with District 21.

Strategic Planning agenda requests should be sent to Chief Kraski. Theresa Ramey is working on an agenda. The Strategic Planning Retreat will include 3-year goals that will be communicated with Administration, Labor, and Commission.

CHIEF'S REPORT

Chief Cermak attended the first evaluation for Blake Smith at the County Training Academy with BC Smith at Snohomish Fire District 4, where this portion of the academy is being conducted. He is doing very well and representing NCRFA well. They were sharing that they are limited on space and places that they can conduct training as places to burn are limited to Gold Bar, the State Academy in North Bend, and Camano Island.

Andy Helms was presented his 40-year service pin and we will recognize him formally during our next banquet.

Chief Kraski and Chief Cermak met with the City of Arlington City Administrator and staff about potential shared services to explore as we move forward.

Letters thanking our Senators and Congressman for support for the AFG grants were sent out letting them know we were not successful in the SAFER grant, however received \$100k from AFG for training and equipment. We educated them that of the \$355 million in SAFER grants distributed to the 50 states, WA State fire agencies were the recipient of less than \$1 million in SAFER Awards. WA State was the 13th most populous state in the nation but ranked 33rd in awards received, not to mention 7th fastest growing state in the nation. We have primed their support for next year's submission and hopefully lobbying for some of the SAFER funding to be routed towards WA State next year.

I met with the Interim Fire Marshal to discuss an Interim Fire Marshal contract. Since our last meeting, Chief Makela has resigned effective 11/30/21. We wish him well in his move back to Spokane area.

Katie Casey and Chris Dickison coordinated and conducted the Lateral Firefighter/Paramedic Test and Oral Boards. We have four solid candidates. Chief's Interviews are occurring and in progress for the above candidates.

The Station 90 water system estimates came in at \$12k for a reservoir tank. The current issue was a water restriction in the Culligan Reverse Osmosis system. They dropped our contract without letting us know and their new management relayed those people no longer work at this office. They have made the repairs to the system and have us back on a service

We currently have 59% of PTE with vaccinations and seven exemptions. We have 64% of FTE that have turned in their proofs of vaccination, but reported all but two FTE with exemptions that are vaccinated and turning in cards before the 18th.
