It was quieter this year but we did experience a fireworks related injury and a burn injury from a motorhome fire at the same location the brush fire started two months ago. The burn victim was airlifted to Harborview for his burn injuries.

Mayor Kelley resigned as Mayor of the City of Stanwood. Chief Cermak would like to thank him for his progressive leadership and service to the community. He is one of the progressive thinkers that saw the opportunity for NCRFA to provide service to the City of Stanwood both under an initial ILA and long term RFA annexation.
