### **BUDGET RESOLUTION**

A RESOLUTION ADOPTING THE BUDGET FOR THE NORTH COUNTY REGIONAL FIRE AUTHORITY ("AUTHORITY"), FOR THE FISCAL YEAR ENDING DECEMBER 31, 2018

WHEREAS, the Authority completed and placed on file with the Board Secretary a proposed budget and estimate of the amount of moneys required to meet the public expenses, bond retirement and interest, reserve funds, and expenses of government of the Authority for the fiscal year ending December 31, 2018; and

WHEREAS, a notice was published that the Authority would meet on November 8th, 2017 at 4:00 p.m., and on November 20, 2017 at 4:00 pm in the George Held Room at Station 99 for the purpose of making and adopting a budget for said fiscal year and giving taxpayers within the limits of the Authority an opportunity to be held in a public hearing upon said budget; and

WHEREAS, the Authority did hold public hearings at that time and place and did then consider the matter of the proposed budget for the fiscal year 2017; and

WHEREAS, the proposed budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the District for the purposes set forth in the budget, and the estimated expenditures set forth in the budget being all necessary to carry on the operations of the Authority for the fiscal year 2018 and being sufficient to meet the various needs of the Authority during that period;

NOW THEREFORE, the Board of the North County Regional Fire Authority, do ordain as follows:

SECTION 1. The budget for the North County Regional Fire Authority for the year 2018 is hereby adopted at the fund level in its final form and content as set forth in the comprehensive budget document, "The NCRFA 2018 Annual Budget", copies of which are on file in the Office of the Board Secretary.

SECTION 2. Estimated resources, including beginning fund balances for each separate fund of the Authority for the year 2018 are set forth in summary form below, and are hereby appropriated for expenditure at the fund level during the year 2018 as set forth in The NCRFA 2018 Annual Budget.
